The Registrar must receive this Registration Form by 04/27/05 to take advantage of early registration fee of \$45. After April 27th, the fee will be \$65 until May 12th. At-the-Door Registration will be \$75. Refunds for cancellation of registration will be as follows: before April 19th: 100%, April 19th–May 12th: 50%, and after May 12th: no refund. Any changes for tours or other functions must be made 24 hours in advance of the date of the tour or function. Refunds for any cancelled tours will be made at the Convention Registration Desk. No refunds will be allowed for meals.
